Investment diversification

The backbone of the Fund's investment strategy is Hansabank's extensive experience in investing in bonds, efficiently combined with global equity investments in all significant regions. 50 per cent of the fixed-income assets are invested in European government bonds, 20 per cent in euro-based corporate bonds, and the remaining 30 per cent in the government and corporate bonds in the Baltic region. The Baltic equity position consists of individual stocks compared to overseas positions, which are made up of index tracking regional exchange traded funds (ETF's). By regions, 40 per cent of equity investments are placed in America, 30 per cent in the Baltic states and 20 per cent in Europe.

Pension Funds are founded on the basis of Funded Pensions Act. The following payment which conditionally consists of two parts - tax (4% portion of the social tax) and contribution (2% contribution of the state funded pension, withheld by the employer on the employee's gross wages) - shall be transferred to the mandatory funded pension account for a person who has joined the funded pension system.
