#### Investment principles

The Fund is a lifecycle fund, meaning that the ratio of instruments carrying equity risk in the Fund's assets will be reduced over time pursuant to the conditions and prospectus of the Fund.




### Asset allocation (%)


## Equity region exposure (%)
