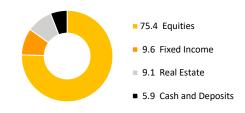

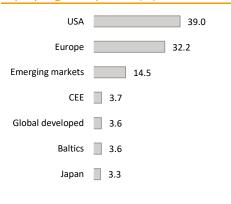
# Asset allocation (%)

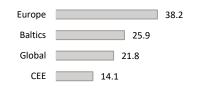
## Equity region exposure (%)
