
#### **Investment Principles**

The objective of the Fund is a long-term growth of the value of the Fund's assets by means of investing up to 50% of the assets in equity-risk securities and alltogether up to 75% in equity funds, equity and other instruments similar to equity and the remaining part of the assets in bonds, money market instruments, deposits, immovables and other assets.





Standard deviation of returns (over the last 3 years)


#### Portfolio by instruments



### Equity portfolio by regions




## Fixed Income portfolio by regions
